KNOWN ALL MEN BY THESE PRESENTS THAT we the \_\_\_\_\_

(i) The decision of the Member-Secretary, National Afforestation and Eco-Development Board, Government of India on the question whether there has been breach or violation of any of the terms and conditions mentioned in the letter of sanction, shall be final and binding on the obligors.

(ii) The Government have agreed to bear the stamp duty if any, chargeable on these presents.
